MPUMALANGA FURTHER ADJUSTMENTS APPROPRIATION ACT, 2000

To appropriate an adjusted amount of money for the requirements of the Province of Mpumalanga in respect of the financial year ending on 31 March 2001

BE IT ENACTED by the Provincial Legislature of Mpumalanga as follows:-

1. Appropriation of adjusted amounts of money for the requirements of the Province of Mpumalanga. Subject to the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), there are hereby appropriated out of the Mpumalanga Revenue Fund for the requirements of the Province of Mpumalanga, in respect of the financial year ending 31 March 2001, as a charge to the Mpumalanga Revenue Account, the adjusted amounts of money shown in the Schedule.

2. Short title. This Act shall be called the Mpumalanga Further Adjustments Appropriation Act, 2000.
