## INVITATION FOR APPLICATIONS AND/OR NOMINATIONS OF PERSONS TO BE APPOINTED AS A MEMBER OF THE MUNICIPAL APPEAL AUTHORITY IN TERMS OF THE SPATIAL PLANNING AND LAND USE MANAGEMENT ACT, 16 OF 2013.

### Attributes

Applicants and/or Nominees must be persons with leadership qualities and must have knowledge and experience in Law and understanding of Spatial Planning and Land Use Management.

### Field/ Areas of interest and Experience

Legal/Law (One person) : Minimum of 5 years

### Term of office

The term of office of the members of the Municipal Appeal Authority will be five (5) years calculated from the date of appointment of such member by the Municipal Council.

### Functions of the Municipal Appeal Authority

The function of the Municipal Appeal Authority will be to consider and adjudicate land development applications which have been appealed from the Municipal Planning Tribunal.

### Applicants and/or Nomination Particulars

Each application or nomination must be in writing and must contain the following details:

- The full names and address of the nominator, who must be a natural persons and a person may nominate himself or herself.
- The name, address and identity numbers of the nominee.
- Motivation by the nominator for the appointment of the nominee to the Municipal Appeal Authority (not less than 50 words and not more than 250 words)
- A short curriculum vitae (not exceeding two pages) of the nominee which must include; full names, identify number, gender, address, telephone, fax, mobile numbers, email address and at least two names of contactable references.
- Certified copies of qualifications and valid registration certificates indicating registration with the relevant professional body and/or voluntary association.
- Letter of acceptance of the nomination from the nominee.
- A minimum experience of 5 years post registration with professional bodies

### Disqualification

Interested persons are encouraged to read Section 38 of Spatial Planning and Land Use Management Act, 2013 (Act 16 of 2013), and failure to comply with the section and the above requirements may result in the disqualification of the application or nomination.

### Remunerations

The successful candidate will be remunerated in accordance with Treasury Regulations that regulate the remuneration of commissions and committees of inquiry, and audit committees.
